Subject: Directions given by the Hon'ble NCBC in their meeting held on 22nd January, 2021 - Compliance regarding.

Sir.

The directions given by the Hon'ble NCBC in their meeting held on 22nd January, 2021 are as under:

- 1. Letters or orders issued so far for the implementation of OBC reservation should be made available to the Commission by 27th January, 2021. For ensuring compliance of reservation in the HEIs, continuous monitoring should be done and strict action should be taken against institutions not complying with the statutory norms and rosters issued by the DoPT.
- 2. It was observed by the Commission that instead of advertising the vacancies of regular posts, adhoc posts are being continued for decades. This practice, on one hand not only prevents the application of reservation norms but the faculty members working on adhoc posts on the other hand are also never certain about their future.
- 3. Liaison Officer should be appointed to ensure the effective compliance of the model roster issued by the DoPT. Keeping in view of a large number of HEIs, the Commission directed to consider appointment of more than one liaison officers.
- 4. It was directed to ensure that the DoPT roster is available on the website of all HEIs.

It is requested to arrange to take necessary action for compliance on the above points and furnish action taken report to this Ministry urgently.
