NOTIFICATION

WHEREAS it has become necessary to reconstitute the Syndicate as per section 21 of the Calicut University Act 1975 by conducting the election to the Syndicate, it is hereby notified that an election will be held without postal ballot according to the principles of proportional representation and in accordance with the procedure laid down in the Statutes on Election to elect the Syndicate of the University; (a) Eleven members (out of thirteen members under Section 21(a) by excluding two Principals of First Grade Colleges under item (ii) of sub section (a) of section 21) elected by the Senate from among themselves of whom (i) Seven shall be persons who are not teachers of whom one shall be a person belonging to a Scheduled Caste or a Scheduled Tribe, and (iii) Four shall be teachers who are not Principals, of whom one shall be a University Teacher and one shall be a Teacher of a Government College. (b) One student member elected by the members of the Senate from among the student members referred to (i) in item no.15 under the heading Ex-officio members, (ii) in Item (12) under the heading elected members and (iii) in Item (4) under the heading other members, in Section 17 of the Calicut University Act 1975.

All members of the Senate on the date of issue of Notification shall be entitled to take part and to vote at this election.

The nomination paper shall reach the Returning Officer, University of Calicut, Calicut University.P.O or cause to be deposited in the box specifically provided for the purpose in the office of the Returning Officer between the hours of 11 a.m. and 3 p.m. on any working day before last date and hour fixed.
