ELECTION TO THE SYNDICATE

GENERAL INSTRUCTIONS

1. Under Section 21 (a) and (b) under the heading of 'Other Members' of the Calicut University Act, 1975 the number of persons to be elected is Fourteen of which Thirteen shall be elected as per Sub Section (a) (i), (ii) & (iii) and One as per Sub Section (b) from among (i), (ii) & (iii)
 - (a) (i) Seven shall be persons who are not teachers, of whom one shall be a person belonging to a Scheduled Caste/Scheduled Tribe.
 - (ii) Two shall be the Principals of First Grade Colleges of whom One shall be the Principal of Government College (The election to this constituency will be conducted for one Principal of First Grade College for want of Principal of Government College in the Senate)
 - (iii) Four shall be the teachers who are not Principals of whom One shall be a University Teacher and One shall be a Teacher of Government College.
 - (b) One shall be the student member elected by the members of the Senate from among the members referred to -
 - (i) in Item (15) under the heading 'Ex-Officio members' u/s 17
 - (ii) in Item (12) under the heading of 'Elected Members' u/s 17
 - (iii) in Item (4) under the heading of 'Other Members' u/s 17 of Calicut University Act, 1975.
2. The elections will be conducted separately on the same day for electing Twelve members u/s 21 (a) (except Principal of Govt. College under item (ii) of sub section (a) of section 21) and One student member u/s 21(b). Separate nomination papers should be submitted for those constituencies. ie, to elect twelve members as indicated u/s 21 (a) (i), (ii) & (iii) and One student member u/s 21(b).
3. All members of the Senate on the date of issue of notification shall be eligible to take part in the election and to vote thereat.
4. Each elector shall be at liberty to nominate a duly qualified person to fill up the seat/each seat.
5. **Every nomination paper shall be proposed by an elector whose name is in the Electoral Roll and seconded by another elector of the concerned constituency with his signature.**
6. **Every such nomination shall contain the consent of the nominee in writing agreeing to serve on the Syndicate of the University of Calicut, if elected, and a declaration to the effect that he is not already a member of the Syndicate of the University or if he is already a member of the Syndicate, his term of office would expire before the membership for which he is seeking election takes effect.**
7. No person shall be qualified for election if he
 - (a) is below twenty-five years of age; or
 - (b) is of unsound mind or a deaf-mute; or
 - (c) is an undischarged insolvent; or
 - (d) has been convicted by a court of law of an offence involving moral delinquency; or
 - (e) has been debarred by any University from appearing in examinations for malpractices in connection with any examination.

Provided that clause (a) shall not apply to a person nominated or elected in the capacity of a student to any of the said authority. Provided further that the disqualification of a person under clause (e) shall cease on the expiry of the period for which he has been debarred.

8. The nomination should be made in the prescribed form as approved by the Vice Chancellor.
9. **The nomination paper should reach the Returning Officer or cause to be deposited in the box provided for the purpose within the date and hour fixed as notified.**
10. (i). The envelope containing the Nomination paper under Section 21 (a) of Calicut University Act, 1975 shall be superscribed **"Nomination for Election to the Syndicate of the University of Calicut - Twelve members other than the student"**.

(ii). The envelope containing the Nomination paper under Section 21 (b) of Calicut University Act, 1975 shall be superscribed **"Nomination for Election to the Syndicate of the University of Calicut - One member from among the student representatives"**.
11. All nomination papers shall be scrutinized by the Returning Officer or other Officer authorised by him on his behalf at the University office on the date fixed for the scrutiny of nomination. The Candidate or his representative who shall be appointed in writing by him and approved by the Returning Officer may be present at the time of the Scrutiny.
